# Venue information

Directions to the <sup>barbeque</sup> wedding venue, Waitoki Lodge Lavender Gardens

- ① Take the Northern Motorway and exit at the SILVERDALE off ramp
- ② Turn sharp left at the end of the off ramp (goes to Dairy Flat)
- ③ Approximately 200 meters along turn right into PINE VALLEY ROAD
- ④ Head along PINE VALLEY ROAD to the very end (about 2-3km)
- ⑤ At the end turn right into KAIHIKATEA FLATS ROAD
- ⑥ Carry on along this road for about 7km until you come to WAITOKI HALL
- ⑦ SLOW DOWN! 50m on you come to the BP GAS STATION on your left
- ⑧ Turn right, opposite the Gas Station, into WAITOKI ROAD
- ⑨ In about 2km you will come to NUMBER 214 on your right
- ⑩ You will notice the number on the letterbox and the WAITOKI LODGE sign in the lavender field
